Supply Chain Security



In order to be able to continue applying efficient import and export processes together in the future, we kindly ask you to support us on the basis of the following information.

The World Customs Organization has defined basic conditions for supply chain security. National authorities are required to transform the requirements of this set of rules into legally binding national regulations. As a result, various countries have enacted regulations on the basis of and in addition to existing security programs, if applicable, which contain optional and mandatory elements in accordance with the SAFE Framework of Standards of the World Customs Organization.

An essential element of these security requirements is the

"Authorised Economic Operator" (AEO). (in Europe: Zugelassener Wirtschaftsbeteiliger)

This is a status granted by national customs authorities to "reliable" economic operators on request, provided that, in return, the company concerned provides evidence of the required security-related standards. The aim of the customs program is to ensure end-to-end security throughout the entire supply chain, from the manufacturer to the end user:



Hirschvogel has been certified as an Authorised Economic Operator (AEO) by the customs authorities. In order to ensure supply chain security, Hirschvogel must prove to the customs authorities that their suppliers and service providers are secure within the meaning of the SAFE Framework of Standards of the World Customs Organization.

Therefore, it is necessary that you confirm one of the alternatives of the AEO Declaration on supply chain security on the following page.
